

## LATEST UPDATE – OCTOBER 22, 2021

In an effort to keep our community partners connected, we are providing you with regular COVID-19 updates.

### COVID-19 vaccine update

As of Oct. 22, 2021, 89.4% of eligible people 12 and older in B.C. have received their first dose of COVID-19 vaccine and 83.9% received their second dose.

In addition, 89.9% of all eligible adults in B.C. have received their first dose and 84.6% received their second dose.

Since December 2020, the Province has administered 8,120,458 doses of Pfizer-BioNTech, Moderna and AstraZeneca COVID-19 vaccines.

### Ministry of Health update

In the Oct. 22 statement on B.C.'s COVID-19 response, 649 new cases were reported with 61 of those in the Vancouver Coastal Health (VCH) area.

The total number of people who have tested positive for COVID-19 in B.C. now stands at 200,898 since the start of the pandemic. There are 5,106 active cases of COVID-19 across B.C. currently.

In the past 24 hours, 13 new COVID-19 related deaths were recorded, while 365 people are currently hospitalized, with 143 of these cases receiving treatment in ICU/critical care. The total number of individuals who have passed away due to COVID-19 is 2,109.

### COVID-19 capacity limits to be lifted

Indoor capacity limits in B.C. will be lifted on Monday, October 25, one day after the Vaccine Card deadline for people to be fully vaccinated to enter certain businesses.

The provincial health officer order restricting capacity limits to 50% for inside organized events and gatherings will be revised to allow 100% capacity in those settings where the BC Vaccine Card is in place and proof of vaccination status is checked. In addition, the requirement to remain seated at a table in restaurants and pubs will be lifted. Indoor mask requirements remain in effect for all indoor gatherings and events.

These changes apply to:

- indoor sporting events (e.g. hockey or basketball games)
- indoor concerts, theatre, movie theatres, dance and symphony events
- indoor organized events: examples are weddings, funeral receptions (outside of a funeral home) and organized parties.

Capacity limits remain in effect where regional orders are in place, including Fraser East and parts of Northern and Interior Health regions. Find the information bulletin [here](#).

## Flu vaccine prevents serious illness

Influenza vaccination is free in B.C. and everyone six months and older is encouraged to get a flu shot.

Seasonal influenza and other respiratory viruses will be in communities alongside COVID-19 this fall and winter. In addition to COVID-19, it has the potential to escalate pressures already faced by the health-care system, particularly if the effects from COVID-19 and seasonal influenza occur at the same time. The Provincial Health Officer, Dr. Bonnie Henry said last year's low influenza rates means our immunity against influenza is lower than usual.

## VCH vaccination clinics

VCH continues to operate several mass-vaccination and pop-up clinics across the region. For a full list of VCH vaccination clinics, including pop-up clinics, please visit <http://www.vch.ca/vaccine>.

All clinics are accepting drop-ins for first and second doses. All are welcome at our clinics, including those without personal health numbers and people who are not residents of B.C. Clinic staff are available to help people register and book appointments at other clinics throughout the region, if needed, and can help answer any vaccine-related questions. All residents are encouraged to still [register on the provincial system](#) to ensure they receive an alert once they are eligible to book their second dose vaccination.

A reminder that people can get their BC Vaccine Card online at [gov.bc.ca/vaccinecard](http://gov.bc.ca/vaccinecard). Once verified, a person will be able to save a digital copy to their mobile device or print a hard copy to present along with their government-issued photo identification when entering designated businesses and events.

People without access to a computer can get their card from a Service BC Centre or by calling 1-833-838-2323 at the Get Vaccinated call centre.

## Vaccine registration for children ages five to 11

Dr. Henry said the province is getting ready to provide COVID-19 vaccines to youth five to 11 years of age as soon as they are approved for use by Health Canada, adding the vaccine could be available to that age group by early November.

In the meantime, parents can pre-register children through the provincial registration system [here](#). Notification of eligibility to book an appointment will be provided as soon as these vaccines are approved for use by Health Canada and the program is set up in B.C.
