COVID-19 testing

B.C. pharmacies distributing COVID-19 rapid test kits

A number of community pharmacies in B.C. are now distributing BTNX Rapid Response® COVID-19 Rapid Test Kits. These kits are rapid antigen tests that work by detecting the antigens (proteins) of the virus that causes COVID-19.

Each kit comes with five take-home tests. The kits are free for eligible British Columbians age 70 and up, and eligible patients can request a kit of five tests once every 28 days.

Update on COVID-19 therapies

Recently, various novel agents have become available in B.C. to treat COVID-19 in mild to moderately ill patients, including sotrovimab and Paxlovid. To be eligible for therapy, patients at higher risk of serious illness must first test positive for the virus. If a patient tests positive with a rapid antigen test, they are asked to report it through the <u>provincial reporting form</u> for provincial tracking purposes. They are then directed to the new provincial <u>online assessment tool</u> to determine if they would benefit from these therapies.

Those who are tested at a Vancouver Coastal Health operated testing site will be assessed and followed up directly if they are eligible for treatment by our newly-established central intake process which operates daily from 9 a.m. - 5 p.m.

Physicians in Vancouver or Richmond who feel comfortable prescribing Paxlovid are free to do so using the tools below. However, if a patient is complex, eligibility is unclear, or if after assessment sotrovimab is the preferred therapy, a referral can be made through the

central intake process by filling out this form and emailing it to: covid.therapy@vch.ca or faxing to 833-222-8131.

In the Coastal Community of Care, the same service can be accessed by contacting the COVID-19 physician on call at 778-984-4075 or emailing CoastallD@vch.ca.

Physicians practicing in the community, or outside of VCH can contact the provincial line (see details below).

Broader availability and prescribing of Paxlovid

As of Mar. 1, all clinicians are authorized to prescribe Paxlovid to their patients who test positive and are eligible for treatment. For patients on additional medications, prescribers are obliged to review the above drug-drug interactions assessment before prescribing. This can be completed using the drug-drug interaction assessment tool above or by contacting the regional Central Intake Team (details above).

Health-care worker vaccinations

Reminder: register and book your COVID-19 booster

Health-care workers who received dose 1 and 2 of a COVID-19 vaccine, and who wants a booster, can register now and book a booster appointment six months after their dose 2 vaccination. Pregnant people 18 years and older can get a booster dose 8 weeks after their second dose. You must make an appointment for a booster dose.

First and second vaccine doses will continue to protect you from COVID-19 until you get a booster dose. A booster dose helps maintain your level of protection as your immunity may decrease over time.

Q&A for medical staff (physicians, nurse practitioners, midwives & dentists)

Question: Do we know the numbers of adults and children in B.C. with long-COVID? How can we accurately and efficiently diagnose long-COVID in the absence of COVID-19 testing?

Answer: We don't have absolute numbers of long-COVID since the Public Health recommendations for testing were changed. We have been working at a network level to ensure we are scaling up our resources, so we can accommodate a fairly large number of people who presumably will develop some degree of long-term symptoms related to the omicron variant.

Regarding the last part of the question, it comes down to how prevalent the omicron variant has been over the past month. Any clinical syndrome with symptoms consistent with omicron would be considered a diagnosis, and if persistent symptoms last for longer than 12 weeks, that would be sufficient to accurately and appropriately diagnose long-COVID.



Incident and Prevalent Cases of COVID-19 in Hospital and Critical Care across VCH/PHC



Hospitalization case count Critical care case count


